



ACCESS ARRANGEMENTS TO COMMISSION BUILDINGS IN LUXEMBOURG

Since 1 April 2018, Commission and other EU pensioners benefit from revised access arrangements to Commission buildings in Brussels (see leaflet published in 02/2018). In this leaflet, we would like to inform you of pensioner access arrangements to Commission buildings in Luxembourg.

COMMISSION PENSIONERS

- ✓ **Reciprocity:** Commission pensioners enjoy the same access arrangements in both Brussels and Luxembourg buildings *independently* of their being assigned to Commission pensioner services in Luxembourg or Brussels.
- ✓ **Access passes:** Luxembourg Commission pensioners receive the same access pass layout as Brussels Commission pensioners.
- ✓ **Luggage, x-ray and metal detector controls:** Commission pensioners are exempt in all Commission buildings in Luxembourg and Brussels.
- ✓ **Visitor escort:** Commission pensioners may escort up to one visitor into the below Luxembourg buildings and the Brussels buildings listed in the 02/2018 leaflet.
- ✓ **Unaccompanied access** for Commission pensioners in the below Luxembourg administrative and social zones, canteens and cafeterias during building opening hours:

- ✓ **Accompanied access** (Commission pensioner access pass + Commission contact person) for Commission pensioners in all other Commission buildings in Luxembourg and Brussels.



OTHER EU PENSIONERS

- ✓ **Reciprocity:** EU pensioners enjoy the same access arrangements in both Brussels and Luxembourg buildings *independently* of their being assigned to EU pensioner services in Luxembourg or Brussels.
- ✓ **Access passes:** EU pensioners are invited to present the pensioner access pass of their institution for access to Commission buildings in Luxembourg and Brussels.
- ✓ **Luggage, x-ray and metal detector controls:** EU pensioners are exempt in the below Luxembourg buildings and in the Brussels buildings listed in the 02/2018 leaflet.
- ✓ **Unaccompanied access** for EU pensioners in the below buildings during building opening hours:
